I am writing on behalf of Quiet Logistics, Inc. ("Quiet") to give you notice that there will be a total closure of its facility located at Park 295 Building B, 2619 Ignition Drive in Jacksonville, Florida on March 7, 2023. This closure is expected to be permanent.

All affected employees have been notified of their separation dates and that their separation from employment will be permanent. Those employees are expected to be separated from employment beginning on March 7, 2023 with all separations expected to be accomplished by March 21, 2023.
