Re: Notice of Permanent Cessation of Operations

Dear Ms. Handberg:

This notice is provided pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"). Universal Screen Arts, Inc. ("Company") is hereby providing notice that effective September 27, 2024, it is permanently terminating its operations and closing its facilities located at: 5581 Hudson Industrial Parkway and 6279 Hudson Crossing Parkway, Suite 100, both in Hudson, OH 44236. This permanent cessation of operations will result in the employment loss for 215 employees, on a staggered basis, with approximately 138 employees terminated on September 10, 2024; approximately 67 employees being terminated on or about September 27, 2024; and the balance of the employees being terminated on or about November 1, 2024. The reason that this notice was not provided earlier is that as of the time that notice would have been required the Company was actively seeking capital which, if obtained, would have enabled the Company to avoid or postpone the shutdown and the Company reasonably and in good faith believed that giving the notice would have precluded the Company from obtaining the needed capital. This notice is being provided as soon as practicable following the Company learning that its efforts at seeking such capital have failed.

The elimination of these positions will be permanent, and there are no applicable bumping rights. A list of the job titles of positions affected and the number of employees affected in each job classification is attached hereto as Exhibit A. All employees have been notified. In addition, simultaneously with this notice the chief elected official of Hudson, Ohio has been notified of the applicable facility closing. None of the affected employees are represented by a union.
