Re: Workers Adjustment and Retraining Notification Act ("WARN")

Dear Program Administrator Handberg, County Administrator Aluotto, and Mayor Pureval:

The undersigned is HR Senior Manager for PepsiCo, Inc. ("PepsiCo" or the "Company"). This letter constitutes written notice to you pursuant to the WARN Act and applicable Ohio state or local laws that, effective December 28, 2024, PepsiCo will be discontinuing its Production Operation at the facility it currently operates at:

Pepsi Beverages Company Cincinnati 2121 Sunnybrook Dr Cincinnati, OH,45237

At present, PepsiCo employs approximately 136 Production Employees at this location. Approximately 104 individuals employed by PepsiCo at this location are represented, for purposes of collective bargaining, by Teamsters Local 1199, affiliated with the International Brotherhood of Teamsters ("Union"). All affected Employees were notified regarding the discontinuation of our Production Operations on October 28, 2024, and have been provided with notices in accordance with the WARN Act.



Currently, PepsiCo has a contract with Teamsters Local 1199 that may afford the impacted union workers bidding rights. However, any bidding rights available to bargaining unit members will be governed by the applicable Letter of Understanding following effects bargaining. All affected employees will be paid wages and benefits through their last day of employment with PepsiCo, Inc. Any retirement and group insurance benefits to which employees are entitled will be provided in accordance with the terms of the applicable employee benefit plans.
