RE: Notice Pursuant to the Worker Adjustment and Retraining Notification (WARN) Act

Dear Ms. Handberg:

Honeywell Intelligrated LLC ("Honeywell") recently announced its intention to permanently close its London, Ohio facility located at 475 E. High Street, London, Ohio 43140. The purpose of this letter is to inform you of anticipated job eliminations, which will begin around **October 31, 2024**, and be completed by **May 29, 2025**.

Honeywell has provided WARN notices to approximately **98 impacted** employees. The International Association of Bridge, Structural, Ornamental and Reinforcing Iron Workers, AFL-CIO, CLC ("Union") represents some impacted employees ("Bargaining Unit Employees"). All layoffs of Bargaining Unit Employees will be conducted in accordance with the collective bargaining agreement in effect between Honeywell and the Union. While Bargaining Unit Employees have bidding or bumping rights as set forth in the applicable collective bargaining agreement, those are not applicable here because all employees are impacted by the site closure. Attachment A has the name of each union/employee representative and the name and address of the chief elected officer of the Union.

Non-Bargaining Unit employees will be offered severance and outplacement benefits, and they do not have bumping rights, which would be inapplicable anyway given the full site closure.

The job titles and employees impacted in each group are summarized in Attachment B to this letter.
