This is to inform you that Anheuser-Busch intends close its AB ONE operations located at **1611 Marietta Ave SE, Canton, OH 44707**. The Company will permanently close and cease its operations at this location on or about October 15, 2024.

As a result of this decision, the Company will be conducting employee terminations during the 14-day period commencing October 15, 2024 and continuing through October 28, 2024. Enclosed is a listing of the job titles of the positions to be affected and the number of affected employees in each job classification. This action is expected to be permanent.

Some of the employees at this facility are represented by the Teamsters Local 92. Any bumping rights provided by collective bargaining agreements are not applicable to this closure. The name and address of the chief elected officer of that union is:
