Re: Announcement of Planned Action (Mass Layoff)

Dear Ms. Handberg, Delaware County Board of Commissioners, and Ms. Riggle:

I am writing on behalf of American Freight Group, LLC and its subsidiaries (collectively, "American Freight") (FEIN: 38-3942066) to provide notice that there will be a mass layoff at American Freight's Delaware, Ohio headquarters facility, located at **109 Innovation Court, Delaware, OH 43015**, as of **March 1, 2025**, due to poor financial performance. This mass layoff is expected to be permanent. There will not be any bumping rights for the affected employees. The date of the first separation will be **March 1, 2025**, and all affected employees are expected to be separated no later than **March 1, 2025**.
