Dear OFFICE OF WORKFORCE DEV:

This notice is being provided in accordance with the Worker Adjustment and Retraining Notification (WARN) Act, 29 U.S.C. § 2102(b)(3).

As of September 9, 2024 Midwest Transport, Inc. ("<u>MTI</u>") has closed all its facilities and ceased all operations other than those required for its liquidation and winding up ("<u>Business Cessation</u>"). The Business Cessation is permanent and occurred at all of MTI's facilities, including:

Prior to the Business Cessation, MTI had been actively seeking an infusion of capital to continue operating. MTI could not give 60 days' notice of the layoff because it would have jeopardized these efforts and prevented MTI from obtaining the necessary capital to continue. While MTI was engaging in such efforts, a large creditor whose loan was in default unforeseeably exercised its right on September 9, 2024 to require the Business Cessation and appointment of a receiver to take possession, custody, and control of MTI's business and assets for the protection of its creditors. This unexpected and sudden demand likewise prevented MTI from giving employees 60 days' notice of the Business Cessation and layoff.

The Business Cessation affected approximately 504 employees, which includes all truck drivers, driver support staff, maintenance workers and support staff, mechanics, dispatchers, managers, regional directors, and all employees other than a few office and administrative staffers who are winding up MTI's affairs and several Fleet Maintenance Managers and mechanics who are cleaning up the terminals.
